## **Vocational Excellence Scanning tool - Context scan**



The initial stages of the strategy requires project partners to learn more about the region and the organisation's that influence or engage with the water industry. The purpose of the scan is to assist Vocational Excellence Training (VET) providers and their stakeholders within the triple helix of the water sector in integrating Vocational Excellence in their organisation's policy, operation and embedding Vocational Excellence closely in the regional innovation ecosystems. The PESTLE model achieves this whilst answering each part utilising a Strengths, Weaknesses, Opportunities and Threats (SWOT summary) approach. This will provide us with the information about the regions to make an analysis of the skills gaps/needs.
